2009 BASH WRESTLING CAMP RULES OF CONDUCT CONTRACT / PERMISSION SLIP

The violation of one or more of the following rules will result in the immediate dismissal from camp

- 1.) Failure to follow any of the Wrestling camp rules (Will be reviewed upon arrival at camp)
- 2.) Drug / alcohol use or possession (As stated in the BASH handbook and the camp rules)
- 3.) Fighting
- 4.) Theft
- 5.) Disrespect of clinicians, counselors or coaches –INCLUDING COACH VENTRESCA
* negative aggressive acts (cursing ,yelling at or arguing with camp staff or other people of authority).
* Purposely damaging or the theft of property. (personal or public)
- 6.) Failure to attend all technique or competition sessions. (Unless given permission)
- 7.) Leaving camp without permission
- 8.) Leaving the dorm room floor after bed check without permission
- 9.) Excessive horseplay or hazing
- 10.) Refusal to attend team meetings while at the camp.
